

Admission Policy

Programs Offered:

- B. Pharm (Bachelor of Pharmacy)
- D. Pharm (Diploma in Pharmacy)

Eligibility Criteria:

1. D. Pharm (Diploma in Pharmacy):

- Candidates must have passed the 12th grade (10+2) examination with Science subjects including Physics, Chemistry, and Biology or Mathematics.
- Applicants should have a minimum aggregate of 50% marks in these subjects.
- Candidates from reserved categories (SC/ST/OBC) are eligible for a relaxation in the minimum aggregate marks as per government regulations.

2. B. Pharm (Bachelor of Pharmacy):

- Candidates must have completed the 12th grade (10+2) with Science subjects including Physics, Chemistry, and Biology or Mathematics.
- A non-zero score in the MH-CET 2024 examination is mandatory.
- Open category students must have secured a minimum of 50% marks in the 12th grade, while reserved category students (SC/ST/VJNT/OBC) require a minimum of 45% marks.

Application Process:

- Online Application: Prospective students can apply online through the official college website or the centralized admission portal of the Directorate of Technical Education, Maharashtra.
- Offline Application: Application forms can also be collected from the college's admission office.

Admission Procedure:

1. **Submission of Application:** Candidates must submit their completed application forms along with the required documents, such as academic transcripts, MH-CET scorecard (for B. Pharm), caste certificate (if applicable), and other relevant certificates.
2. **Merit List:** Admission is based on merit, which is determined by the candidate's performance in the qualifying examination (12th grade) and the MH-CET score for B. Pharm applicants.
3. **Counseling and Seat Allotment:** Shortlisted candidates will be called for counseling sessions where they will be allotted seats based on their merit rank and availability of seats.
4. **Document Verification:** Candidates must undergo document verification during the counseling process to confirm their eligibility and finalize their admission.
5. **Payment of Fees:** Upon successful verification, candidates must pay the prescribed admission fees to secure their seat in the program.
