- 4) Sophisticated instruments to be purchased as per the norms.
- 5) Fire safety needs to be upgraded.
- 6) More efforts are required for teaching to improve student results.
- 7) Industry linkages need to be strengthened and need efforts for student placement.
- 8) Cleanliness needs to be improved in the college.
